

**Announcement of the  
International German Team Championship 2016/2017 (1.Bundesliga)**

- Organizer:** German Boxing Federation (Deutscher Boxsport-Verband e.V.)
- Local Organization:** Participating teams in 1. Bundesliga
- Participating Teams:** Clubs who register their participation on basis of this announcement; the German Boxing Federation decides about validity of registrations.  
At time of the registration, the respective club must not have any financial obligations to the German Boxing Federation.
- Weight Categories:** 57 kg, 61 kg, 65 kg, 70 kg, 76 kg, 82 kg, and +91 kg
- Legal Background:** Valid competition rules of the German Boxing Federation, the valid code of legal procedure of the German Boxing Federation as well as this announcement.
- Eligible Boxers:** Boxers having a valid AIBA record book or a record book of the boxing federation of their country.
- Boxers who permanently live in the country the registering club is member of
- Per day of action at least three of the appointed boxers must have the nationality of the land in which their club is member.
- All athletes must be elite boxers (19-40 years, determined by year of birth)
- Mode of Competition:** In 1. Bundesliga, all teams compete in match an rematch.
- Every bout consists of three rounds of three minutes each with a break of one minute between the rounds.
- Dates:** The dates for every day of action are determined after expiration of the deadline.
- Assignment of R&Js:** For 1. Bundesliga, the R&J chairman of the German Boxing Federation nominates four referees and jugdes as well as a supervisor.  
In international events, there will be two neutral referees and judges.  
For all events, a German R&J will be appointed as supervisor.
- Hint concerning Evaluation:** The R&J chairman of the German Boxing Federation will check every bout and event protocol. When detecting mistakes, the supervisor will be asked and the found mistake will be corrected. The involved teams will be informed directly about changes in result.
